13 SALIENT POINTS - LEAGUE FORMAT

1. Matches will be played on Saturday, Sunday & Monday over 1 weekend.
2. Match days shall commence on Saturday, Sunday & Monday morning.
3. Each team shall comprise of a maximum of 9 players (minimum 6) per team.
4. Each player to be fielded once per match.

2.0 RULES OF THE TOURNAMENT

2.1 ELIGIBILITY & REGISTRATION

1. A maximum of 16 Teams will be eligible to participate, the selection of which is subject to the tournament's committee decision on the final teams accepted.
2. Each team shall register a maximum of 9 players and a minimum of 6 players. Only **one National player** ie represented in Davies Cup, SEA Games and Olympics since 2005 are allowed to be registered in any teams. The list of names of each playing team must be submitted for registration on the entry forms provided. Non-registered players are not allowed to participate. Players may be called to identify themselves, if deemed necessary. No changes to the list will be entertained after the Team Managers' meeting on **24th April, 2010 (Saturday) at MBPJ Sports Complex (Tennis Center), Kelana Jaya at 8.30 am**

3. No player may sign for more than one team. Any player who contravenes this rule will be disqualified from the competition.
4. Entry Fees must be paid before any Team is allowed to participate.

2.2 TOURNAMENT FORMAT

The Inter-team League will be played at the MBPJ Kelana Jaya Tennis Courts on Saturday, Sunday & Monday morning from 9.00 am.

Teams will play on a round robin basis during Round 1. The top two teams in the respective Groups qualify for the Quarter Finals/Semi-finals, which will be on a knock-out basis. There will also be a plate event for losing quarterfinalists.

2.3 CHALLENGE FORMAT

Matches will commence at 9.00 a.m. sharp.

1. Each tie shall consist of **three (3) doubles matches** and each player is allowed to play **once**. The three doubles are:-
 - 1 men's doubles open
 - 1 men's masters doubles (35 – 44 years)
 - 1 men's veteran doubles (45 & above)
2. Each tie shall be of the best of 2 tie-break sets, with super tie-break in the case of 1 set all. Play shall be continuous.
3. The order of play shall be as follows :
 - ◆ Men's masters doubles 35-44 years
 - ◆ Men's veteran doubles 45 & above
 - ◆ Men's open doubles
4. The Team Manager of each team shall, before commencement of each tie submit to the Officer-in charge by 8.45 am, the order of play and no change shall be allowed thereafter.
5. Players failing to turn up for play at the prescribed time or when called upon to play, will be defaulted after a grace period of 15 minutes.
6. Preliminary round will be played on a round robin format whereupon the top two teams in the group will advance to the quarter-final/semi-final knock out stage.

CHALLENGE SCORING

Preliminary Round - Round Robin Format

Points for each match will be awarded as follows :-

Each doubles won	3 points
Each doubles lost	1 point
Each doubles forfeited (Walk over)	0 point

In the event of a tie in the points scored at the end of the round, winning teams will be decided according to the following criteria (in order of listing):

- Team winning the tie in the preliminary rounds.
- Number of doubles won
- Number of sets won.
- Number of games won
- A toss of a coin by an arbiter.

Incomplete matches which may occur due to poor light, weather conditions or other reasons shall be resolved prior to the commencement of the next match.

Quarter Final / Semi –finals and Finals – Knock Out Format.

Upon completion of the round robin, the knock out pairing will be decided by a draw to be decided by the organizing committee.

The winning team shall be decided by the total matches won upon completion of the 3 doubles matches.

3.0 GENERAL CONDITIONS

1. The Tournament shall be conducted in accordance with the ITF rules.
2. Umpires may be provided from the semi-finals onwards.
3. Proper Tennis Court attire must be worn. Shoes must be of flat rubber sole type.
4. Competitors play at their own risk on the Tennis Courts. STA, the sponsors (if any) and organisers will not be held responsible for any personal injury or loss of any other mishaps during the tournament.
5. In all aspects, the decision of the Tournament Referee shall be final.
6. The Referee reserves the right to vary the match competition in any appropriate manner due to inclement weather for the successful completion of the Championship.
7. **The Organizing Committee reserves the right to vary the prize money offered in any event which attracts less than 16 entries.** This decision if any will be published on the notice board at the beginning of the championships.
8. The Challenge Trophy will remain the property of Selangor Tennis Association.
9. All appeals/objections must be made in writing accompanied by fee of RM 200/- shall be lodged with the Tournament Referee not later than 1 hour after the conclusion of the said game. The decision of the Appeal Committee is final. If appeal is rejected, the RM 200 will be forfeited
